The Study Group on the Co-Production of Public Services

Earlier meetings organized by the study group established a small-scale, active, and sustainable network of scholars and practitioners focused on the co-production of public services. The study group provides a forum to discuss challenging research on innovations in public service delivery that include citizens' co-production. The study group has collaborated extensively to publish special issues in international public administration journals and a comprehensive book on co-production in a comparative international context. The study group seeks to promote close intercontinental collaboration among co-production scholars, including establishing joint research programs and developing a shared database of international case studies and survey data on co-production.

Conference Topics

Co-production refers to the involvement of both citizens and public-sector professionals in the delivery of public services. Although countries differ in the extent to which citizens play a role in the provision of public services, the practice of co-production is gaining ground around the world.

The overarching goal of this study group meeting is to advance our conceptual, theoretical, and empirical understanding of co-production. To that end, we are particularly interested in papers that tackle the complexity of co-production in terms of frameworks for analysis, applications of relevant theory, and empirical study. We hope that through our work we can also contribute to an increased understanding of the practice of co-production.

The goal of this conference is to promote theory and ideas for new research emphasizing a comparative view of co-production. Thus, the main theme of this conference will be devoted to:

- Context (geographical, cultural, political, economic, inter-organizational networks)
- **Actors** (local government, politicians and bureaucrats, non-profit organizations, individual or organized citizens)
- **Tools** (ICT, media and various community platforms)
- **Impact** (on the community, providers, society, political and administrative leaders in (local) governments involved in coproduction initiatives and services)

Studies that use innovative qualitative or quantitative methodological approaches are of particular interest. We also welcome a variety of disciplinary and interdisciplinary approaches. Submissions are particularly encouraged from doctoral students working on the topic of co-production.

Meeting Format

Paper Presentations and Educational Tour

The meeting will consist of presentations of individual papers. Full papers will be made available to all participants in advance of the meeting to deepen the discussion. Each presenter will have an opportunity to discuss a paper of another colleague. The meeting will conclude with a roundtable conversation about the study group's plans for intercontinental collaboration in co-production research. In addition, on the second day we will arrange an educational tour of the municipality of Haifa and see examples of co-production in action.

The meeting of the Study Group on the Co-Production of Public Services will take place at the University of Haifa, Israel from 19 - 20 May 2020.

Cost

The registration fee is 140 Euros. Participants are responsible for their own travel and accommodations.
